Application Form

What is Canadian Tire Jumpstart?

Jumpstart gives kids a sporting chance. Jumpstart funding helps families that need a financial hand with registration, equipment and/or transportation costs. The program covers a wide array of sports and recreational programs, including basketball, soccer, martial arts, day camp, tennis, yoga, and more!

Criteria for Funding:

- Parent/guardian must demonstrate financial need.
- Children must be between 4 to 18 years of age.
- Applications are reviewed on a case-by-case basis. Funding is provided based on availability of funds.
- Reimbursements for program costs already paid by (or on behalf of) the family shall not be granted.

Sports and Recreation Guidelines:

- The program is designed to get children active. Participation must be in an organized sport or recreational activity.
- Funding goes to support an individual's participation in an activity, not to support teams or groups or to create an inventory of equipment.
- Funding should be for a sustained program that is either a minimum of five weeks duration with a minimum of one session per week or, in the case of sport camps, five consecutive days.

How to apply:

1. Families must **fully** complete the application with their most updated information. Applications may be accessed at the following locations:

- Parks & Recreation Main Office

2. Attach an income document from the latest tax base year along with your completed application (we recommend using your Canada Child Tax Benefit and Ontario Child Benefit Notice as proof of your family income).

3. Applications may be submitted to any City of Windsor community centre or to the Parks & Recreation Main Office on 2450 McDougall Street, Windsor, ON N8X 3N6.

4. Families will generally be notified within 1 - 2 weeks of submitting their application. However, please note that depending on the volume of applications we may receive, the notification period may be subject to change.
